There is no charge for geld and brand additions.

PHOTOGRAPH REPLACEMENT: If you would like to have the photograph on the front of the certificate replaced with a more current picture, please submit a 3/4 left or right side view photograph using AQHA's guidelines for taking photographs. There is a replacement fee for updating the photograph.
